



RODRIGUES REGIONAL ASSEMBLY

MAIN DECISIONS

Executive Council Meeting – Friday 23rd January 2026

The Executive Council met today under the chairmanship of the Chief Commissioner, Mr. Franceau Aubret GRANDCOURT, G.O.S.K; and has among its deliberations:

DECIDED

- (i) That the Chief Commissioner's Office, Commission for State Land will proceed with the launching of tender for Consultancy Services for the implementation of a Land Administration and Management Information System in Rodrigues in order to facilitate the efficient use of land and land-related resources for the advancement and well-being of the population.
- (ii) That the Commission for State Land proceeds with procedures for the allocation of lots on the reclaimed land at Baie aux Huitres.
- (iii) To approve the procedures to be used for the allocation of lots in the parcelling zone at Anse-Ally for Commercial/Industrial Projects for Tourism Activities.
- (iv) That the Chief Commissioner's Office, Commission for Environment proceeds with the project 'Desilting of Riverbeds Located in Villages using under the Community and End User Participation procurement method.

- (v) To approve in principle the construction of new public toilet blocks at Pointe Coton, Fumier and St Francois public beaches.
- (vi) That the Deputy Chief Commissioner's Office, Commission for Education will provide a one-off grant to the Parent Teacher Associations (PTA) of all Primary Schools for the acquisition of 'Welcome to School Pack' for pupils to be admitted in Grade 1 on 12th January 2026.
- (vii) That the Commission for Education in collaboration with the Mauritius Institute of Education (MIE) will proceed with the organisation of a Graduation Ceremony on 6th and 7th February 2026 at the Gymnasium near Polytechnics Mauritius Ltd at Baie Malgache.
- (viii) That the Commission for Education will provide capital grants to the Parent Teacher Associations (PTAs) of some Government Primary Schools to undertake minor upgrading works in view to provide a safe and conducive environment for effective learning and teaching.
- (ix) To approve that the Commission for Vocational Training proceeds with the launching of bids for the Upgrading works at Antoinette Prudence Human Resource Development Centre.
- (x) That the Commission for Vocational Training will meet costs related to the delivery of Training Programme by the Mauritius Institute of Education (MIE) in Rodrigues.
- (xi) That the Commission for Trade and Licenses will proceed with the issue of Trade Licences , pending amendment and subletting of the leases as appropriate and to refer the cases to the Cadastral Office for processing and finalisation of the appropriate commercial leases.
- (xii) That the Commission for Trade, Commerce and Licensing will proceed with the enlistment of seven (7) interviewers for two (2) additional months in order to complete the Licence and Trade Survey.
- (xiii) That the Deputy Chief Commissioner's Office, Commission for Public Infrastructure will proceed with the launching of bids for the Framework Agreement for Maintenance, Upgrading, Resurfacing and Construction of Roads in Rodrigues.
- (xiv) To approve '*in principle*' that the Commission for Cooperatives and the Commission for Fisheries make a request to the Registrar of

Cooperatives to appoint a caretaker board to manage the affairs of the Bus Operators of the Rodrigues Multi-purpose Co-operative Society Limited and the Rodrigues Offshore Fishermen Cooperative Federation Ltd (ROFCF) respectively.

- (xv) That the Commission for Health will provide return air tickets to two(2) delegates from Rodrigues for their participation in the World Autism Day 2026 which will be held on 11th April 2026 in Reunion Island.
- (xvi) That the Commission for Housing will provide housing assistance to five (05) vulnerable families under the Infrastructure Development for Needy Families, Casting/Recasting of Roof Slab Scheme and the New Social Housing Scheme on humanitarian ground.
- (xvii) That the Commission for Family Welfare will proceed with consultancy services for the setting up of a Parenthood Observatory in Rodrigues to monitor and assess the status of parenthood, create space for dialogue and disseminate parenting-related policies and programmes.
- (xviii) That the Commission for Family Welfare will proceed with the purchase of construction materials in favour of the Centre de Formation Agricole de Frere Remi for the implementation of the programme 'Autonomisation des Familles'.
- (xix) That the Commission for Family Welfare will proceed with the launching of bid for the setting up of a Family Recreational Area at Oyster Bay and Graviers.
- (xx) That the Commission for Handicraft will outsource the services of a photographer in view of the preparation of the craft magazine to be launched on 21st February 2025.
- (xxi) That the Commission for Arts and Culture will provide return air tickets to a Rodriguan Singer for his participation in the Seggae Jam Session 2026 (2nd Edition) on 24th January 2026 in Mauritius.
- (xxii) To approve the proposed activities to be organised by the Commission for Arts and Culture to mark the 58th Anniversary of the Independence and 34th Anniversary of the Republic of Mauritius.
- (xxiii) That the Commission for Youth and Sports will provide a financial grant to the Rodrigues Regional Football Committee for the purchase

of trophies and medals in connection with the holding of the Republic Cup and Regional Leagues for 2025-2026 season.

- (i) Of the status position regarding the Schemes of Service, Filling of Vacancies and Assignment of Duties at the level of the Rodrigues Regional Assembly.
- (ii) Of the outcome of the mission of a delegation from the Commission for Environment, headed by the Chief Commissioner in Mauritius from 13th to 15th January 2026 with regard to the promotion of Renewable Energy and Circular Economy.
- (iii) That the Commission for Education have made necessary arrangements for the four (4) Laureates of the HSC 2024 Examinations to attend the reception organised by the Office of the President at the State House House, Reduit on 29th January 2026.
- (iv) That at its meeting held on 6th January 2026, the Licensing Committee has approved four (4) applications for the issue of Trade Licence.
- (v) That the Deputy Chief Commissioner's Office will proceed with the disbursement of fund in favour of the Rodrigues Public Utilities Corporation (RPUC) representing operating grant for the month of December 2025.
- (vi) Of the successful completion of work commissioned by Blue Zone Mauritius Ltd for the restauration of Grundfos High Pressure Pumps and Control Panel at Mourouk Pumping Station.
- (vii) That the Commission for Public Infrastructure will convey its no objection to the National Development Unit to undertake the project 'Raising of Ford at Riviere Coco', Rodrigues.
- (viii) That the Commission for Public Infrastructure has issued letter of acceptance for the Upgrading of the Stairway Path from Baie Lascars to Creve Coeur.
- (ix) That the Commission for Child Development will organise sensitisation campaigns on Child Abuse and Child Grooming from 9th to 28th April 2026

in view of increasing public awareness, warning signs and long-term effects.

- (x) That the Commission for Family Welfare will proceed with the award of contract for the setting up of a Family Recreational Area at Reposoir and a Family Nature Park at Marechal.
- (xi) That the Commission for Women's Affairs will proceed with the launching of bid for the setting up of a market fair at Petite Butte on 23rd January 2026.
- (xii) Of the launching of bids for the setting up of a Family Resource and Wellness Centre at Pointe Venus Phase 1 by 23rd January 2026.
- (xiii) That the Commission for Arts and Culture will provide return air tickets to a Slammer for his participation in the final of Slam Poetry Competition in Mauritius on 24th January 2026 in the context of the Commemoration of the 191st Anniversary of the Abolition of slavery.
