**MAIN DECISIONS**

**Executive Council Meeting – Friday 01 March 2024**

**The Executive Council met today under the chairmanship of the Chief Commissioner, Mr. Johnson ROUSSETY, G.O.S.K; and has among its deliberations:**

**DECIDED**

- (i) To approve further processing of thirteen (13) applications for commercial and industrial projects and five (05) applications for land permits for small-scale commercial activities.
- (ii) That the Commission for Water Resources will carry out bidding exercise for the procurement of materials for water treatment in view of providing better quality of water to the population.
- (iii) That the Deputy Chief Commissioner's Office will put one Skid-Steer Loader at the disposal of Rod Clean Ltd against increase shareholdings, for the cleaning of roadsides and collection of waste.
