MAIN DECISIONS

Executive Council Meeting – Friday 13 June 2025

The Executive Council met today under the chairmanship of the Chief Commissioner, Mr. Franceau Aubret GRANDCOURT, G.O.S.K; and has among its deliberations:

DECIDED

- (i) That the Chief Commissioner's Office, Commission for State Land will relocate agreeable unbuilt lessees of Riviere Banane and Montagne Croupier parcelling zones.
- (ii) To approve the transfer of state land leases for the running of a commercial complex over a portion of state land being part of the reclaimed land at Camp Du Roi and Jean Tac.
- (iii) That the Commission for Vocational Training will provide sponsorship to three (3) candidates to pursue their studies for a Master in Psychology with specialization in Clinical Psychology, a Diploma in Film Production and Airline Pilot Licence respectively.
- (iv) To approve that the Rodrigues Educational Development Company (REDCO) Ltd proceeds with the recruitment of a Warden and a part-time Cleaner for the Rodrigues Student House.
- (v) To approve that the Rodrigues Public Utilities Corporation awards contract for Electromechanical Works for the Primary Water Network from Pointe Coton to Petit Brûlé Reservoir.
- (vi) That the Commission for Trade Licence will issue one (1) Trade Licence, pending amendment and subletting of the leases as appropriate and to refer the cases to the Cadastral Office for processing and finalisation of the appropriate commercial leases.

TAKEN NOTE

- (i) That Mr. Maurice ALLET, Chairman of the Mauritius Ports Authority has led a delegation to Rodrigues since 9th to 13th June 2025 in connection with the Port Master Plan and port related matters.
- (ii) That the Trade and Licencing Unit will proceed with the renewal of Trade Licences for financial Year 2025/2026 as from 1st to 31st July 2025.
- (iii) That the Licensing Committee at its meeting held on 5th June 2025 has approved six (06) applications for the issue of Trade Licence.
- (iv) That at its meeting held on Tuesday 10th June 2025, the Building and Land Use Permit Committee has approved the grant of nine (09) Residential and one (1) Commercial Building and Land Use Permit.
- (v) That the Commission for Price Fixing will organise awareness campaigns on the Price Fixing Information System (PFIS) around Rodrigues as from 7th June 2025 for traders, retailers, "tabagie" owners, village committee members and villagers.
- (vi) That the Commission for Arts and Culture will provide assistance to eight (08) local contemporary dancers for their participation in the Biennial of Dance organised by the Seychelles National Institute for Culture, Heritage and the Arts from 14th to 26th July 2025.
- (vii) That in the context of the International Day Against Drug Abuse and Illicit Trafficking which is observed annually on Thursday 26th June 2025, the Commission for Youth and Sports will organise talks and cultural activities for students, parents, teachers and trainees of vocational institutions with the collaboration of various stakeholders at the Cultural and Leisure Centre of Mon Plaisir.
